
PARTY HUNT – Sika Lodge

There will be a total of six shooting stations, each of which will require a total of four to five shots at gongs of varied sizes and at varied distances, the event will not be timed but a maximum time per shooting station and per shooting position will apply.

A marshal will be at each shooting station to advise distances, the required order of shooting and the designated position for each shot.

Each shooter will be required to supply their own ammunition, maximum calibre is 8mm, no magnums short or long, no automatics – semi only, also no tracer or armour piecing ammunition permitted.

Participants are advised to bring/wear their normal hunting gear, please particularly ensure that appropriate foot ware and ear muffs/plugs are worn.

There is a maximum of 25 entries only, there will be prizes awarded to the top twelve shooters and this will be judged on accuracy, the decision of the marshal at each shooting station is final as is any decision made by the Range Officer of the day.

It is mandatory that all shooters be present prior to commencement for a briefing by the Range Officer/Organiser on range/gun etiquette, safety requirements for the day, range rules, terms and conditions.





Hi All,

CDFGC Gong Shoot – Sunday the 4th of October. (More info attached)

The first one is being hosted by the Central Districts Field and Game Club (CDFGC) on a property just out of Colyton (between Fielding and Ashhurst, just north of Palmerston North) on Sunday the 4th of October. Malcolm and I will be running this event again for the club. This is a hunter event (30 shots, targets out to 300m, no magnum calibres). See the attached club notification for more information.

Tarata Medium Range – 21st and 22nd of November.

The second event is the Tarata Medium Range Precision Event to be held on a property outside of Tarata, in Taranaki. This event involves a centre fire course on the Saturday and a rim fire course on the Sunday. This event will be held on the 21st and 22nd of November. The centre fire course will be broken down into a Hunter class (25 shots, targets out to ~300m) and an Open class (50 shots, targets out to 600m). We will allow calibres up to 300WinMag for the centre fire event. The rim fire event will be strictly limited to 22LR only and will involve some moving targets and longer distance targets, although the majority of targets will be between 10m and ~80m. Competitors will complete the course in squads of three or four.

Still have quite a few details to sort out with this event but accommodation will be made available for those people travelling that don't mind fitting in. Also a large

proportion of the funds raised from this event will go to the Taranaki Sporting Shooter Hub (name to be confirmed) – a new range facility we are looking at here in Taranaki.

Limited entries to both events. Get in touch with the CDFGC for entry into their event and get in touch with myself if you are interested in coming along for one or both days for the Tarata event. I will announce more details for the Tarata event closer to the date.

GOVT: PUKEKO CULL WENT 'HORRIBLY WRONG' – 3 NEWS (26 AUGUST 2015)

The killing of four endangered takahe was the result of a culling operation that went "horribly wrong", Conservation Minister Maggie Barry's office says.

Labour's Ruth Dyson has released an email which explains why Deerstalkers' Association hunters were chosen to carry out a pukeko cull on Motutapu Island.

"The choice of using NZDA hunters was not due to cuts in funding, but rather a way of getting all New Zealanders engaged in conservation in some form or another," the email from Ms Barry's office says.

"Unfortunately, in this case while the intent was good, things went horribly wrong."

The Deerstalkers' Association has apologised for the killings.

The birds were shot last week during the organised cull to cut down the number of pukeko on the island.

The birds look similar, although pukeko can fly and takahe can't.

The hunters had been told to only shoot pukeko on the wing.

There are fewer than 300 takahe left.

Ms Dyson says it's ludicrous for Ms Barry's office to say the hunters were used as a way of spreading the conservation message.

"The email also claims the Department of Conservation is actually at its highest level of funding in history and claims that rumours of funding cuts were unsubstantiated," she said.

"That is just tosh, as the annual funding in real terms in 2015 is a whopping \$65 million below the 2008/09 figure."

PIG HUNTER'S FIRST-AID IN MACGYVER STYLE BY TIMOTHY BROWN – NZ HERALD (24 AUGUST 2015)

A Palmerston hunter used his T-shirt and duct tape as a tourniquet before hobbling more than 200m to meet his rescuers after impaling his leg on a stick in the Maungatua Range.

Luke Direen was pig hunting off Grainger Rd, near Outram, when he fell and impaled his leg on a stick about 10.30am yesterday.

"I slipped on a dead flax bush and just arsed over and a stick went into my leg," he said casually after being discharged from Dunedin Hospital yesterday afternoon.

"It went three inches into my calf muscle.

"I pulled it out - apparently it's not a good thing to do. You are supposed to leave it in there.

"I didn't really think about that. It wasn't on the top of the to-do list."

It left a wound big enough that a paramedic "could put two index fingers inside my leg".

The pain was immediate, he said.

"The pain was pretty good - it was right up there."

He contacted police with his cellphone to report the accident and then applied his own form of first-aid.

Mr Direen did not have a first-aid kit with him, as "I didn't take my dogs with me", so he used his T-shirt as a tourniquet, applied further pressure with duct tape and used his rifle as a crutch as he hobbled back towards the track more than 200m away.

Emergency services arrived within about 30 minutes of the fall and he was winched out by the Otago Rescue Helicopter about 12.25pm.

"They were awesome about everything and the speed they did everything with is unreal," he said.

Constable Amie Manning said Mr Direen had "done everything right".

"There's nothing else he could have done to make it any better," she said.

"He was very well prepared, wearing fluoro gear, had a cellphone, enough food,.. a locator beacon and GPS."He was in "good spirits" when emergency services arrived despite the "stab wound" in his leg, she said.

Mr Direen said despite initial concerns he would need surgery, a doctor had "stitched my leg and a couple of tendons" and he would return to Grainger Rd with his "mum and a mate" to get his truck yesterday afternoon. It was a tale he expected to hear about at the pub.

"My mates are going to give me a bit of stick for it," he said, with a laugh.-

GRIEVING DOG OWNER BELIEVES 'PEST POISON' MAY HAVE KILLED HIS DOG BY AMBER-LEIGH WOOLF – STUFF.CO.NZ (24 AUGUST 2015)

A Lyall Bay resident who watched his beloved dog die an agonising death is warning Wellington dog owners to be aware of poison in the area.

Stefan Prentice suspected Frankie swallowed poison after she wandered from his property on Hungerford Rd, which backed onto council land.

Frankie, an 8-year-old border collie whippet cross, died last Monday morning after returning home unwell the night before.

Her health rapidly deteriorated and she started vomiting, shaking, struggling to breathe and suffering fits, before dying.

The popular dog was well known around Wellington for joining Prentice, who worked at Regional Wines and Spirits by the Basin Reserve, on his delivery runs.

"She went with me to work, she went everywhere with me."

While it was unknown what had killed his pet, he believed Wellington City Council needed to keep the public better informed about where it laid poison for possums.

It used brodifacoum with each bait station holding a maximum of 1kg of bait and stations spaced at 100m.

Prentice believed the poison was strong enough for the council to warn dog owners, so it should be treated with caution.

"They do say on the website not to let your dog off the lead and off the road".

While devastated about his dog's preventable death, he hoped publicity might prevent another dog owner losing their pet.

"I know my dog was poisoned, and she died. I'd hate for it to happen to someone else."

Wellington City Council confirmed there were possum bait stations near Prentice's home on Te Raekaihau headland.

"There's strict rules around the signs that do go in. For example, at every reserve entrance, there's a sign in the area," the council's open space and parks manager, Amber Bill, said.

The council had only heard of two dogs poisoned by possum bait in the past decade.

"Two cases have been brought to our attention where anti-coagulant has been found in the dog's bloodstream. But we still don't know if that's from the bait in the area."

The council did everything it could to ensure people's pets were safe, Bill said.

Council spokesman Clayton Anderson said the risk of dogs becoming poisoned from bait stations was low.

"A 20kg dog would need to eat its own body weight of bait or 6kg for several days in a row, which is very unlikely to occur."

Natural poisons, such as karaka berries, could be to blame, and slug baits were a common cause of dog poisoning in urban areas, he said.

Wellington SPCA spokesman Mark Collyns was unaware of an influx of dogs consuming poison.

However, he said Prentice's experience was a warning to other dog owners.

"They need to be wary and cautious about having their animals around the bush."

Collyns said if owners found their dog has been poisoned, they needed to seek immediate veterinary care.

COUNCIL ADAMANT WATER WON'T BE AFFECTED BY 1080 DUMP – 3 NEWS (22 AUGUST 2015)

Auckland Council is reassuring residents drinking water won't be affected by a dumping of 1080 poison.

Hunua Ranges, Waharau and Whakatiwai regional parks and tracks in Auckland are closed while the poison is laid to kill pests.

Aerial application of poisoned bait over a section of 12,500 hectares began on yesterday morning.

Areas would be closed for up to five days, while the tracks are cleared, the council says.

Water supply reservoirs in the area have been isolated from the public water supply.

They won't be returned to service until consecutive samples show no 1080 has been detected, and the Medical Officer of Health signs it off.

Young children and dogs were particularly at risk of 1080 poison and people in the area should heed warning signs, the council says.

Dogs owners in the vicinity should watch them carefully and prevent them scavenging carcasses.

Why 1080?

- Rats and stoats take eggs from nests of native birds
- Possums damage the native fauna
- The last kokako breeding season in the Hunua management area produced no fledglings
- Four out of five monitored kokako breeding pairs outside the management area were missing.

HUNTERS NO LONGER ABLE TO 'FARM' ANIMALS BEFORE COMPETITION BY MARK PRICE – NZ HERALD (10 AUGUST 2015)

Hunters tempted to "farm" wild deer or pigs before hunting competitions are likely to be out of luck at the Upper Clutha Deerstalkers Association competition later this month.

The association, which is holding its popular annual competition for the third time, has changed its rules, mainly to encourage more interest in hunting among women and children.

But the changes also aim to sideline hunters who manipulate the competition process by allowing wild deer or pigs to graze crops on farmland over the winter.

That improves the animal's chances of winning competitions where prizes are awarded for the heaviest animal.

Organiser of the Upper Clutha competition Russell Duff told the Otago Daily Times the issue had led to the association's recent rule change.

As a result, the top prize at this year's competition, on August 28, will go to the animal closest to the average weight of those shot, and a "judges' choice" prize would be awarded for what they considered the "best animal" in each category.

There are categories for red and fallow deer, goats, pigs and other hoofed species, such as tahr and chamois.

"If we have a prize for the average weight ... it gives everyone a chance," Mr Duff said.

Pig hunter Duncan Stewart, of Bannockburn, who won the prize for the heaviest pig last year, was nonplussed about the change yesterday, saying most competitions now operated in the same way.

He competed in four or five competitions a year, for the social benefits rather than financial gain.

Mr Stewart said it was hard to tell when a wild animal had received extra feed, but he recalled one event where the signs were fairly obvious.

"A pig came in that looked like it had been fed on grain for the last year and a half.

"But you never know."

Mr Stewart said while the average pig might win the prize money, his aim was always to return with the biggest.

"You still want to get the biggest pig. Even though it's not the best prize, everyone wants to have the heaviest one there."

There will still be prizes at the Upper Clutha competition for the heaviest animal in some categories.

These include hares, rabbits and possums shot by junior association members.

The association is offering \$10,000 cash, goods and services as prizes.

DARYL CRIMP: HUNTING PART OF NZ'S NATIONAL IDENTITY – NZ HERALD (05 AUGUST 2015)

The killing of Cecil the lion generated a seemingly unprecedented level of outrage, and public condemnation of the individuals involved.

The outpouring of anger, disgust, and vitriol on social media was akin to Lord of the Flies dystopian mentality, which resulted in the persecution of the hunter, without trial. It spawned many opinion pieces, such as Sandra Kyle's highly emotive All hunting is animal cruelty.

Those who argue against hunting and hunters often rely on emotive language, aspersions and convenient truths, and Kyle's piece certainly doesn't disappoint. References to beheading, destroying animals, painful lingering deaths, and

disrupting nature's patterns, is sensationalism and does little to bring perspective to the debate.

Hunting is an integral and necessary part of nature, whether it is man doing the hunting or another predator.

In New Zealand we have no natural predators so hunters fill that role and they do play a useful part in pest control and helping to maintain healthy balanced animal populations.

Ms Kyle's argument that, left to her own device, nature will balance out with natural predators killing the sickest and the weakest, doesn't apply here. Nor is it entirely true of other places in the world, because we now live in a highly modified environment and that Utopia no longer exists. Nature now also controls by population imbalance, disease and starvation.

The idea that hunters cause stress and fear to animals thereby compromising their immune systems and making it harder for them to thrive is nonsense. Fear and stress in the animal kingdom are the natural defence mechanisms that help keep animals alert and alive, and are necessary if populations are to thrive.

Animals are part of a natural order whereby everything that eats ultimately gets eaten, so to argue that hunting is cruel is drawing a long bow. The reality is that death by 'hunter' is generally quicker and less painful than death by natural predator.

Animal rights protagonists do try to distort the notion of hunter cruelty by bestowing human characteristics on animals, thereby making the act appear abhorrent. This is called anthropomorphism. An example is naming a lion Cecil and calling it a 'celebrity', thereby making it easy for people to make a human connection with it. It is, in fact, a wild cat with no human characteristics and no idea that its name is Cecil. Animals don't, can't and won't ever possess human attributes or qualities.

Kyle's tenuous reference to the psychology of hunters' motivation is weak and aspersions of narcissism, arrested development, suppressed anger, and a desire for domination, are spurious, inflammatory, and insulting. If that were the case, none of us would have passed our firearms licence test!

The reality is that most hunters are intelligent, well-adjusted, successful, compassionate individuals who invest heavily in conservation and animal welfare. Worldwide, hunters' dollars contribute to animal preservation, habitat protection and restoration, animal recovery and breeding programmes, anti-poaching programmes, jobs, and local economies. Why? Because in order for hunting to exist, animal populations must be abundant and healthy. Hunting is not about the extermination of a species but sustainable off-take.

Contrary to Ms Kyle's belief, hunting is a highly skilled pursuit that requires a lot of an individual: ability, fitness, agility, tenacity, self-discipline, determination, marksmanship, leadership, co-operation, judgement, empathy, control, and a vast array of outdoor skills, to name a few. Hunting is also an important part of our identity as a nation. And let's keep it in perspective: killing is only a very small part of

the act of hunting - it is the full stop at the end of the sentence. In order for us all to eat, something must die - no matter how you dress it up.

I would argue that the debate is not about cruelty, but that hunting offends some people's sensibilities - and that's okay, but it's not a reason have it banned. Perhaps animal rights groups would be better served working with hunters, rather than attacking them. After all, don't we want the same things: more animals in the wild, healthier populations and better habitat. Surely compromise is a better way to an end goal that serves all.
