Make a submission on the discussion paper on the future management of St James Conservation Area. 3. KAHURANGI NATIONAL PARK MANAGEMENT PLAN – closes Friday September 4th 2009.

Enclosed in the mail and available electronically on request a paper that outlines: Public meetings, information on the five matters being reviewed. This draft partial review of the Kahurangi National Park Management Plan has been prepared in accordance with Sections 46 and 47 of the National Parks Act 1980. This statutory document reviews parts of the existing Kahurangi National Park Management Plan 2001. The Department of Conservation has prepared this partial review of the management plan in consultation with key stakeholders, the Nelson/Marlborough Conservation Board, iwi, and other interested groups and individuals. The Department notified its intention to carry out a partial review of the plan in July 2007 and received 160 written suggestions. The Department has taken into account those suggestions in the development of this draft partial review. When approved, the partial plan review will be effective for the life of the existing Kahurangi National Park Management Plan.

MEETING WITH WALKING ACCESS COMMISSION – 30 July 2009 - A report is in the mail to the branches and available electronically on request. The walking access commission meeting with landowner and recreational stakeholders was amicable and helpful. The act is broader than expected. The meeting was primarily to discuss the draft access behaviour code and the commission's draft strategy, both of which are required by the act. See www.walkingaccess.org.nz

POISONING OPERATIONS

1. OPERATION EGMONT – 33,000 hectares, 1080, between august and December 2009

2. WAIKATO POSSUM CONTROL PROJECT, 25,000 ha north-west Waikato

DOC UPDATES - POLICY ON DEER REPELLENT USE – 2009 - in the mail to the branches and available electronically on request.

COLFO

UNLAWFUL POSSESSION OF FIREARMS – COLFO has recently verified the following with the police.

It appears the police are taking a stronger stance in situations where people have failed to renew their firearms license before expiry; this is the instruction issued to Arms Officers.

- Where the holder of a firearms licence has not applied for a new licence and has let their licence expire, and they possess firearms, they do so unlawfully
- > The firearms are not to be left in possession of the former licence holder
- Unless there are exceptional circumstances enforcement action, including prosecution, and application for the forfeiture of the firearms is to be carried out
- That they have continued to possess firearms unlawfully must be considered in the overall assessment as to their fit and proper status in any future application for a firearms licence

POSITIVELY IDENTIFY YOUR TARGET POSITIVELY IDENTIFY YOUR TARGET

Gary Howat, chair COLFO said this isn't a change in policy – it is a correct application of the law. Garry added COLFO would expect that were a person was warned of offered diversion rather than prosecuted surrender of destruction of their firearms would be part of the agreement. The last point here is a concern: it appears more emphasis on destruction.

RECENT ADVOCACY

Enclosed in the mail to the branch and available electronically on request:

1. MT ASPIRING NATIONAL PARK DRAFT MANAGEMENT PLAN, which includes

- No helihunting
- > Keep the Lower Dart Conservation area outside of the park
- > NZDA supports the helicopter landing sites for recreational hunters in the park
- > Red deer, Whitetail and chamois should be a valued recreational resource in the park
- Some accessible areas of open tops reserved for recreational hunting
- > WARO and helihunting enforcement in the park

Conclusion: NZDA believes that the plan is too extreme of its protection of native vegetation beyond reasonabless and the requirements of the National Parks Act. NZDA requests that greater recreational

hunting use of the park be encouraged and fostered – this includes viewing deer and chamois as a recreational and food resource, which is guaranteed a permanent place in the park.



FEARS FOR KIWI AFTER MAULING - THE DAILY POST BY ANITA MORAN

Kiwi are still surviving in the Whirinaki Forest - but only just.

The Department of Conservation (DoC) is concerned dogs are killing off the kiwi population in the forest - there are about 200-300 kiwi left.

A male kiwi was found dead in the Okahu Valley recently and Department of Conservation ranger Sarah King said it was most likely mauled by a dog.

"The injuries are consistent with being mauled by a dog. This is the fourth kiwi in the Whirinaki that is known to have been killed by a dog."

The kiwi, called Tame te Ngeru, had been monitored since 2005 and has produced at least 11 healthy kiwi chicks since then. One of his chicks was also killed by a dog, in 2007.

The kiwi was part of the BNZ Operation Nest Egg programme. Males are monitored and eggs they are incubating are taken from the forest to Rotorua's Rainbow Springs. Once hatched, the chicks are reared before being released into the wild.

Ms King said that since 1999, more than 90 kiwi chicks had been released into the Whirinaki to boost and replenish the population.

This year 19 chicks were hatched and were being returned to the forest, four of them Tame te Ngeru's offspring.

"The kiwi have no defence against dogs.

Dogs are simply too strong and fast," Ms King said.

"The dogs don't even eat the kiwi, they just chase them and grab them for sport and then leave them to die."

She said the Okahu Valley was a popular hunting area and dogs were regularly used to hunt pigs there.

Over the past five years free kiwi-aversion training has been offered for dogs to prevent them needlessly killing kiwi.

"However not all dog owners are coming to the training and this is the result," Ms King said. "It only takes one dog and once a dog starts killing kiwi, it will keep doing it."

She said it took just six weeks for one pet dog on the loose to kill 400 kiwi in Northland.

"A kiwi-killing dog loose in the Whirinaki could decimate all the hard work that has been done over the last 10 years in a matter of days."

Ms King said kiwi-aversion training was free and anyone taking dogs into the bush should do their bit to protect kiwi by having their dogs trained.

SEARCH FOR MISSING HUNTERS - NZ HERALD

A search and rescue team is preparing to look for two hunters overdue in the Ikawhenua Ranges, south-west of Whakatane.

Sergeant Andrew O'Reilly, of Whakatane police, said the two men pig hunting in the hills did not show up at their meeting point overnight.

At this point, Mr O'Reilly said the police were "erring on the side of caution".

He said it would have been cold in the ranges overnight, but the weather was otherwise good.

He believed both hunters were experienced and one was a former Department of Conservation officer.

6466: THAT'S HOW MANY LOCALS HAVE GUNS - THE DAILY POST BY MATTHEW MARTIN

More than 6400 people in Rotorua hold a licence to own firearms.

Latest figures, released to The Daily Post, show that by May this year, 6466 people - or about one in every ten locals in the Rotorua area - hold a firearms licence.

Officially, this is an increase of 1520 from 2007.

But Rotorua District Arms Officer Mike Keefe said he has not issued that many new licences in that 17-month period and there were a number of reasons for the increase.

Mr Keefe said the increase was due to re-licensing and a change in how police record information.

"In 2001 there was an upgrade of our computer system and file transfers from around the country are part of that figure, but the majority are re-licences."

He said he had issued about 150 new licences so far this year and did not expect that number to top 300.

The figure of about 1 in 10 people in Rotorua holding a firearms licence was about in line with the national average, even though the district had a high rural population and excellent hunting conditions.

He said the figure also changed when taking into account about 100-150 people dropping off the list due to death, non-renewal of old licences and moving out of the district.

Mr Keefe said five recent shooting incidents in the area in less than a month were a concern but "not one of those individuals involved held a firearms licence".

International gun control advocate and former Fair Go presenter Philip Alpers said he felt the recent spate of shootings in Rotorua were out of the ordinary and there was no need to panic.

But he said New Zealand was lagging well behind other western nations in gun control.

"I guarantee every one of those firearms were obtained somehow from a licensed gun owner.

"Whether they were stolen, borrowed or sold."

He said more than 90 per cent of guns in New Zealand were not registered and New Zealand was one of just two western nations who did not require gun registration - the other country being the United States.

"Like a driver's licence, the person obtains the licence to drive any car and the object, the car, is registered."

A local gun club spokesman, who would not be named for safety reasons, said law abiding firearms owners were not the problem and were normally staunch supporters of the police when it came to gun control.

"Nobody likes that sort of stuff going on but they do seem to be drug or gang related."

The spokesman said it was also a reflection on New Zealand that frontline police officers still did not carry firearms on them.

"That still amazes me, but the situation may change in the future," he said.

New Zealand's Council of Licensed Firearms Owners board member Andre Doyle told The Daily Post the five reported shootings in less than a month was a concern.

"It is high but we have been trying to help police with policy to control this," Mr Doyle said.

"Rotorua encompasses a lot of rural communities and as sad as that [the shootings] is it means those people have access to weapons when they shouldn't have," Mr Doyle said.

NIGHT GOGGLES USED TO FIND TRAMPER – NZ HERALD

Night-vision goggles helped a rescue helicopter crew find an injured tramper in the Tararua Range on Monday.

The 38-year-old man injured his knee during a walk over Cone Saddle and had to crawl 600 metres through snow in search of a cellphone signal, the Dominion Post reported.

The Westpac rescue helicopter was sent and around 8.30pm spotted the man's head torch through the goggles.

"We can pick up a white light from kilometres away and it's an amazing safety enhancement," operational manager Dave Greenberg said.

Search and rescue head Senior Sergeant Murray Johnston said the man was well equipped for a day-tramp, but had not been prepared for a night in the open.

Te Papa chief executive Seddon Bennington and his tramping companion, Marcella Jackson, died of hypothermia in the same mountain range this month.

Dr Bennington, 61, and Mrs Jackson, 54, were found in the snow in the Tararua Range on July 15, four days after they went missing.

KEA SURVIVING 1080 DROPS - NZ HERALD

A study into whether kea are being killed by drops of 1080 poison has found no deaths so far among the kea being monitored.


Last year concerns were raised about the poison, used to control pests and predators, after seven kea died at Fox Glacier.

The Department of Conservation (DOC) study monitored 13 kea which were caught and tagged at Kahurangi National Park, Tasman, in June.

A month after 1080 aerial drops in the area all 13 were still alive.

DOC scientific officer Josh Kemp said the focus would now shift to kea nesting results over the next two years to see if they were benefiting from the pest control.

"We would expect kea nests to do well in the Mt Arthur area this year as aerial 1080 operations achieve large reductions in numbers of possums, rats and stoats that prey on eggs and chicks."
